

Bosch Commercial Industrial Heating Promotion ("Promotion")

Terms & Conditions



1. The specific rules set out in these Terms & Conditions shall be incorporated into the Competition Rules ("**Rules**") which shall apply to this Promotion. A printed copy of the Rules can be obtained by sending a stamped addressed envelope to: Bosch Thermotechnology Ltd, Cotswold Way, Warndon, Worcester, WR4 9SW United Kingdom, stating the name of this Promotion. By entering this Promotion, entrants agree to be bound by these Terms & Conditions and the Rules. In the event of a discrepancy between these Terms & Conditions and the Rules, these Terms & Conditions shall prevail.
2. The promoter is Bosch Thermotechnology Limited, a company incorporated in England and Wales with company number 01993294, whose registered office address is at Cotswold Way, Warndon, Worcester, WR4 9SW United Kingdom ("**Promoter**").
3. Employees of any company within the Bosch group of companies (including BSH Home Appliances Limited) and their immediately family members, Bosch's agents, authorised retailers or their employees, or any person professionally associated with this activity (or members of their family or household) may not participate in this Promotion.

To be eligible to participate in the Promotion

4. The Promotion will commence on 01 October 2015 and close on 31 May 2016 ("**Promotional Period**").
5. The Promotion is open to all Pipe Center merchant centres in the United Kingdom (each an "**Eligible Participant**" and together the "**Eligible Participants**"). The Promotion is not open to merchant centres in the Republic of Ireland.
6. The Promoter assumes that by entering the Promotion (and you warrant that) you are aged 18 or over.
7. If you are entering the Promotion as an employee of an organisation then you have an obligation to (i) inform your employer about the Promotion, and (ii) obtain the permission of your employer to enter the Promotion.

Qualifying Product

- (each a "**Qualifying Product**" and together the "**Qualifying Products**");

- 8.1.2 register the Enquiry with the Promoter's relevant sales manager by phone or email;

- 8.1.3 produce a project quotation in relation to the relevant Qualifying Product; and

- 8.1.4 receive an order for the Qualifying Product which is a direct result of the Enquiry; and

- 8.2 obtain Verification (as defined in paragraph 15) of delivery and installation of the Qualifying Product.

- 9 The Promotion only applies to Qualifying Products which have been supplied and distributed by the Promoter within the United Kingdom. The Promoter will not accept any Qualifying Products that are purchased from alternative markets.

- 10 This Promotion is not available on any second hand or graded stock.

The Reward

11. The reward is a £200 love2shop voucher (the "**Reward**").

12. The Reward is non-transferable and there is no alternative. The Promoter reserves the right to substitute awards of equal or greater value at any time.

How to claim the Reward

15. Following receipt of the Claim, the Promoter will not send the Reward to the Eligible Participant until it has provided the Promoter verification of the delivery and installation of a Qualifying Product by post to the address stated in clause 14 ("**Verification**").

16. Any Claim received after the Closing Date will not be accepted. Please do not include the purchase price or any other prices on the Claim.

17. Only complete Claims will be accepted and failure to provide all of the necessary information and/or documentation will invalidate your Claim. The Promoter does not accept any responsibility for claims that are lost, incomplete, illegible, corrupted or fail to reach the Promoter by the Closing Date for any reason.
